Dear Governor Murphy:

As members of the SUNucate Coalition, including medical specialty associations, patient, public health, and other groups, we write to express our sincere gratitude for your proposal to exempt sunscreens from sales taxes in New Jersey. We believe this would be a significant step in promoting skin cancer prevention by increasing access to an essential skin protection measure, and thereby potentially reducing the long term financial burden associated with skin cancer treatment.

Sunscreens are an essential public health tool to help prevent skin cancer¹, the most common form of cancer in the U.S.² With nearly 130 miles of coastline, regular sunscreen use is a particularly important preventative measure for the over 120 million people who spend extended time outdoors enjoying New Jersey's beautiful beaches. Eliminating sales tax on sunscreen products will help advance greater access to this vital form of sun protection for residents and visitors alike.

In addition to being the most common form of cancer, skin cancer is also very costly to treat with annual medical costs of \$8.9 billion in the U.S.³ Medical expenses associated with the diagnosis and treatment of skin cancer impose a significant financial burden on individuals, families, and the state's healthcare system. At the same time, many skin cancer cases can be prevented with reduced overexposure to ultraviolet (UV) rays and increased sun protection.⁴ Exempting sunscreen from sales tax is a sound investment that will encourage more people to adopt sun-safe habits and save both lives and healthcare costs overall.

We commend your leadership and commitment to public health through this forward-thinking proposal. By making sunscreens more affordable and accessible, New Jersey would be setting an example for other states to follow in prioritizing preventative healthcare measures. We look forward to supporting your proposal and collaborating with you and your administration to promote sun safety across New Jersey.
