After the Committee has completed their review, an email notification will be sent to the PRIMARY AUTHOR of the poster, advising whether or not the poster has been accepted. If not accepted, feedback will be provided and you may be asked to make changes and resubmit the abstract. If your abstract is accepted, it is a requirement that the primary author attend convention (purchase a full convention registration) and that an author listed on the abstract, preferably the primary author, must be present during the designated poster presentation times, on Wednesday, February 23 rd and on Thursday, February 24 th , 2022 to answer questions about your poster.					

Abstract Submission Guidelines

- For project abstracts, authors are expected to clearly state the title and purpose/goal/objectives of the poster
- We will consider "encore" posters, or posters that may have already been presented elsewhere, as long as the content is still current and relevant
- Briefly describe the manner in which the study or issue was addressed and the findings, conclusions or solutions
- Clearly suggest ideas about the possible relevance of your work for nurses and/or other interdisciplinary health care professionals, in other settings and contexts
- Use 12-point Times New Roman regular font. Use upper case lettering only if applicable
- Maximum of 250 words and must fit abstract template
- Please apply the following headings into your abstract:
 - 1) Title
 - 2) Background of Study/Inquiry
 - 3) Purpose of Study/Inquiry
 - 4) Methodology/Methods, Analytical Approach
 - 5) Findings/Implications

- By submitting your abstract, you understand and agree that should your submission be accepted, the primary author must attend convention (purchase a full convention registration) and that an author listed on the abstract, preferably the primary author, must be present during the designated poster presentation time to answer attendee questions about your poster.
