



Discussed of LPNs in Derm Tactic-MAC committee was discussed. There is agreement that the DNA will continue to focus on accurate count of respective membership and determining need for programming.

Discussion of activities of various DNA local chapters was discussed. Dissolution of chapter, the process therein, and distribution of respective funds is discussed.

Ongoing efforts by the DNA to promote and investigate engagement will continue and increase, including creation of summative reports.

Pending action items were reviewed by the board.

GP licensing updates were discussed. Software platforms and their lifecycles were considered, along with expirations. Status of support, security, and system patches were considered to minimize risk to DNA. The DNA will upgrade security licensure and will plan 5 years in advance.

Strategic planning is discussed, including verbiage for listings of elected positions within DNA. Appropriate respective changes are planned to ensure accuracy.

Unanimous consent that is utilized for HPASC was revisited and affirmed. Sign-on letters for advocacy will also be added to monthly meeting agendas, keeping members informed. DNA membership with advocacy organizations and associated fees were discussed and considered for renewals or discontinuation Vacant nominating positions discussed and possible replacements considered and will be pursued.

Repurposing of presentations was discussed, including the need to ensure proper copyrights are considered with all published enduring education. The DNA will actively ensure proper steps are taken to have consent and rights of use, while utilizing resources including DNA's Accredited Provider Program Director and the Board. Updated verbiage for online speaker agreements that were initiated were discussed.

Strategic tactics related to LPNs and MAs in dermatology work force is discussed, as are current membership data. Need for accurate credentials and need to obtain accurate counts of professional groups is considered.

Dermatology staff on-boarding projects as pilot opportunities for DNA were discussed.

The September 2023 Board of Directors meeting was cancelled.

## HEATHER DANA, RMA, CDT, CLINICAL LEAD

## What do you get out of being a volunteer for DNA?

I have been a member of the DNA since 2013. It was not until I saw an e-mail from the DNA looking for volunteers to create a task force to help determine the knowledge and skills necessary for Medical Assistants in Dermatology that I submitted my resume and a brief reason why I felt that I should be considered for this task force. I have enjoyed sharing my personal experience in Dermatology as a Medical Assistant, for the past 11 years, and the Medical Assistants that have been part of the office I work for and some of the skills and knowledge that were not taught and/or learned and how that individual was being set up for failure. I feel like I have a voice and am heard within the Task Force. I've enjoyed working as a team to develop a survey to send out to all members of the task force, DNA members and share within our individual work environments to collect data from Doctors, Mid-levels, Nurses, and Medical Assistants to help form the basis of the national competencies used to guide educational endeavors for Dermatology Medical Assistants. I have also recently joined the Membership Advisory Council (MAC) of the DNA. This group helps develop ideas to maintain membership, acquire new memberships and encourage members to get involved in the DNA. This group also works on different campaigns to help promote important issues in Dermatology, like Healthy Skin month for November which includes a flyer to help educate patients that can be shared amongst all dermatology offices. This committee has a very diverse and extensive background and I have found that all ideas and comments are listened to. As part of the Membership Advisor Counsel, I look forward to my continued growth and ways to contribute to this group as I learn more about what areas MAC as the ability to reach, support and create excitement and longevity of membership in the DNA.

### How has volunteering with DNA enriched you as a person?


knowledge and recent practices in Dermatology. If you want to become more active, there are multiple committees to reach out to that provide the opportunity to be as involved as you wish to be

My favorite part about the MA Task Force has been the group brainstorming to come up with the guestions for the survey we administer to find out from Medical Assistants, Nurses, Mid-Level Providers and Doctors what they see as the most important attributes a Dermatology Medical Assistant should have. The data we collected is still being analyzed by the statistician, but I am really looking forward to what our data will show. I am also very eager to see what the next step the data will take the Task Force. It would be very exciting to have a hand in developing the national competencies used to guide educational learning and criteria for Dermatology Medical Assistants. I am still relatively new in the Membership Advisory Counsel, but I really like being focused on acquiring new membership, maintaining the current membership and increase participation within the DNA, whether through committees, Annual Convention, offering incentives to encourage other members to enroll new members, etc. I have enjoyed the personal touch of reaching out to new members to be able to provide them with a point of contact/liaison for the DNA. As a new member, it is overwhelming to figure out where to start and how to get involved. I look forward to discovering other avenues of the Membership Advisory Counsel and opportunities to assist the DNA.

## What are some projects you are currently working on within your committee?

I need to focus mainly on the MA Task Force to address this question. I can remember my first meeting with the Task Force, and I was very nervous and not sure how my ideas, opinions and interactions would be perceived. I was pleasantly surprised that it is quite refreshing when you have a group who has joined together that has very similar bottom line goals. So much creativity and productive communication just begins to happen. It is very exciting and rewarding seeing the parts of the survey come together and then once the data was collected, having all that information sent off to a statistician to be analyzed. Each of us had an opportunity to compose a part of the research piece that will be published once all the final information has been received from the statistician. It will be very exciting to continue to follow this information and the next steps that it leads the DNA in helping to create the National Competencies for Dermatology Medical Assistants.

## **How to Automate Staying Up-to-Date**

During the holidays, we are reminded how busy our lives are and how fast time flies when we are taking care of matters in personal, work, and family sectors. As the Health Policy, Advocacy, and Scanning (HPASC) committee works on finalizing an easy tool kit for all nurses to reference in daily advocacy efforts, I thought it was poignant to send some easy and quick tips to automate staying informed and up-to-date with research.

These are free, easy, and quick tips to select the most important information to be summarized and sent to your email for quick digestion.

## Google Scholar (scholar.google.com)

- Visit the main search page, this is great to focus a search to bodies of research.
- To automate alerts, go to the left-hand menu and select alerts.
- Choose the search term and enter your email. You can change the frequency of emails in the settings menu.

## **Congress (congress.gov/get-alerts)**

- There are many ways to get notified of federal legislation. You can follow the prompts on this page depending on your needs.
- The saved search, bill activity tracking, on the floor today, and committee reports are helpful.

## **Google Trends (trends.google.com)**

- This is a way to filter and sort Google search terms.
- It has a slight learning curve, but it is robust.

For example, a local community searched for "skin cancer" 30 times more than baseline in the past week because a local community leader discussed plans for shade installation at a park.

We hope these tools are helpful for you, your community, and your practice. Look forward to our Advocacy Toolkit related to dermatology nursing coming in the Spring!



## DERMATOLOGY NURSE PRACTITIONER CERTIFICATION BOARD

Dear Colleagues, this is the time of year recertifications are being submitted and completed. Currently the Dermatology Nurse Practitioner Certification Board (DNP-CB) reviews 100% of all applications and recertifications that are submitted. This process is time-consuming and occasionally tedious for all those involved. The process is not always easy, possibly anxiety provoking but necessary in order to continue to uphold the highest standards of the exam and recertification. We appreciate all those who go through the certification and recertification process. In order to evaluate the process of becoming certified and recertified the DNPCB will be sending out a survey in the near future to all those who have become certified. We do this for several reasons. The first is to evaluate whether the current processes are still pertinent and relatively straight forward for applicants to go through. The second is to identify any issues that span applicants. The third is with the national accreditation that was completed by the board through the Accreditation Board for Specialty Nursing Certification (ABSNC) it is imperative we monitor how the process affects applicants and make changes as we are able. Another item that will be coming to those certified is a practice analysis survey. A practice analysis is a way to examine tasks performed by entry level practitioners and the knowledge needed for competent practice. This is done in order to evaluate

the current scope of practice for certified dermatology nurse practitioners. The practice analysis will examine disease states, medications, etc., that are pertinent to what we do every day. This data is analyzed and then used by the DNPCB and CNET to establish appropriate disease diagnoses that will be used in future exams. The practice analysis directly affects the content of the exam. We ask that when you receive the surveys to take a few minutes to answer the questions in order for us to keep our application process and practice analysis continually updated. In addition, it will be imperative for those certified to have updated email addresses available. This can be completed through the Dermatology Nurse Practitioner Certification Board website by clicking on the log in section. If you do not have a current account one can be created by clicking on the forgot password. To become a Dermatology Certified Nurse Practitioner takes dedication to ourselves, commitment to our patients, and the responsibility to each other to continue to improve in all aspects of what we do. For the DNCPB that includes the exam, certification, and recertification process. We ask all of you to continue to help us improve.



## On the Job

## What is the biggest benefit you get from your DNA membership?

The biggest benefit I get from my DNA membership is the education. The annual Convention is hands down the best way for me to remain up to date and continue to learn. ## What advice can you give people to get more involved with DNA?

## Describe your first experience with DNA.

My first experience with the DNA was in 2014. I had the opportunity to present on the topic of Wound Care at the Annual Convention in Orlando. The convention is what sparked my desire to learn more about dermatological conditions, especially those that affect the patients I was seeing. This even led to me becoming certified in dermatology nursing. I often say, if you are looking at wounds, you are also looking at skin and if you are looking at skin, you are also looking at wounds!

What is your proudest career accomplishment? Landing my dream job! Like so many people, Covid had a significant impact on my life and career, and I felt that I needed a change. I was always interested in industry work, but I felt that my location and, at the time when my children were younger, my inability to



make a long commute or travel were barriers to me pursuing this line of work. A medical device company in the Chicago suburbs had an opening for a clinical scientist and with Covid, more jobs became remote, which removed the barrier of a long commute. I applied for this job and after my first interview, was told they were not interested in moving forward with the hiring process with me as I did not have as much experience in a key area as what they were looking in this role. It was disappointing to be turned down for the job, but at this point, I had learned enough about the company to know that I wanted to work there. I continued to watch for other opportunities. After a couple of months, I noticed that the position I had originally applied for was not yet filled. I also noticed that they slightly modified their requirements for the position and that the one area where I did not have much experience in was no longer required, but preferred. I sent an email to the HR contact from my first interview and listed in bullet points how I met each one of their requirements and asked to be reconsidered for the role. I received a phone call the next day and successfully went through the interview process to be offered the position. I like to tell people, especially my FNP students, this story because it was a great lesson on how persistence can pay off!

## What is your name?

Sherry

#### What setting do you work in?

I work as a nurse practitioner at Leo Dermatology in Enon, Ohio. I started Leo Dermatology over 10 years ago as a nurse practitioner-led clinic. Leo Dermatology can provide excellent skin care to a population that is medically underserved, and many are underinsured or have no insurance. Leo Dermatology currently has two nurse practitioners who provide care to patients of all ages, ethnicities, and income levels.

How long have you been a nurse practitioner? 23.5 years.

How long have you worked as an NP in dermatology or a dermatology-related discipline?

18.5 years.

## Describe your role as an NP in your practice and the healthcare team.

I have two distinct work roles, a clinical role, and an administrative role. My main position is that of a clinical nurse practitioner. Every day I work closely with the office clinical team that is made up of Medical Assistants, an LPN and an RN. My patient appointment times and procedures vary; therefore, every day is different. The clinical role includes being an educator for nurse practitioner students, physician assistant students and medical residents. My goal is to provide the student with an opportunity to put their basic knowledge to work while introducing more interesting and unusual aspects of dermatology care. I enjoy teaching procedures and watching the novice become a pro.

My secondary role is that of an owner, operator, and administrator at Leo Dermatology. This is the part of the job that is not easy. Somedays I want to give the responsibility away and other days I relish that I am leading my destiny. I work closely with the biller and office manager. Staffing, scheduling, and billing are dynamic and frequently need to be assessed and reassessed to prevent problems. The most practical advice I offer is a reminder to read the contract you are signing not only as a future employee but as an ex-employee. Your new job is exciting, but did you ever stop to consider what happens if the position does not work out? Have an attorney read your contract, they do not have the emotional investment that you have. Continuing education through conferences is fantastic. Engage in your local dermatology groups. Become a DNA member, you will be able to connect with so many diverse and interesting professionals. Have fun applying what you learn.



## NURSE PRACTITIONER IN DERMATOLOGY

A nurse practitioner in dermatology is a clinician who offers holistic, high-quality care for their patients. They have advanced clinical training beyond their initial professional registered nurse preparation with a master's or doctoral degree and advanced education and training in the specialty. Many nurse practitioners also achieve dermatology nurse practitioner certification demonstrating a higher degree of professional competence. Nurse practitioners are highly-trained dedicated professionals who are trusted by both patients and other healthcare providers.

Expertise in dermatology is accomplished through specialty training or completion of a post-graduate internship program. In addition, the dermatology nurse practitioner participates in independent continuing education activities such as those offered by professional organizations such as Dermatology Nurses' Association (DNA).

Increasing health care needs are driving the growth of the profession. Nurse practitioners in dermatology provide high-quality comprehensive care for diverse patient populations, increase patient access to healthcare services and decrease wait times to care.

Nurse practitioners in dermatology emphasize the patient-centered holistic approach to dermatology through expert care, comprehensive examination, clear communication and continuity of care.

- Orders and interprets diagnostic tests

- Works with other health care professionals to provide comprehensive care




## JDNA CORNER: FIRST IMPACT FACTOR FOR JDNA!

Have you heard? In June 2023, Journal of the Dermatology Nurses' Association received its first impact factor, with an initial score of 0.4! The impact factor is a measure of average citations to recently published content.

Why is the impact factor important?

- It gives potential authors a benchmark for how often papers are cited in a particular journal.
- It is a powerful tool for comparing journals in a similar subject category.
- It removes bias favoring large journals over small ones, more frequently issued journals over less frequently issued ones, and older journals over newer ones.
- It gives a complete and accurate assessment of journal performance.


